Re: Garbage Licensing Fees and Permitting Requirements

Dear Sir/Madam:

Attached please find a renewal application for Carting Permits to operate in the Village of Patchogue. Please read all the regulations concerning your permit and return with your signed application and fee by December 31<sup>st</sup>.

The fee for annual registration is \$500 per company for garbage removal in containers.

All dumpster companies are responsible for the construction and maintenance of the enclosures which are required by Village Code. Acceptable enclosure material shall be a six-foot chain link fence with privacy slats and similar locking gates, or split face masonry block with chain link gates. The Village, before construction must approve the location of all enclosures. For all dumpsters and enclosures placed on Village property, applications must follow the same enclosing requirements. Since space on Village property is limited, it is advised that businesses work together to share dumpsters. All dumpsters placed on Village property require a certificate of liability insurance in the amount of at least \$1,000,000 naming the Village of Patchogue as additional insured. This certificate must accompany all applications or permits will not be issued.

All dumpsters shall be marked with the name of the company in contract. Any container with an improper name will be subject to removal at the company's expense to our municipal yard. It is also the responsibility of your driver to close and relock the enclosure gates after emptying the containers. Failure to do so will constitute a violation of Village Code.

Anytime a new client in the Village of Patchogue is added to your company, the Village must be notified. The same holds true for any canceled accounts. If we do not receive your application by December 31<sup>st</sup>, no permit will be issued.
